This Addendum consists of three (3) pages.

PRE-BID MEETING NOTES: Held November 18, 2019 at 10:00 AM

- 1) There are 27 regular education routes and 10 special education routes up for bid. The bid is due on December 3, 2019 at 10:00 am. Bid opening will take place in the Challenger Portable.
- 2) Contractors were reminded to be in "Good Standing" with the State of Maryland Tax Office.
- 3) The bid opening is on December 3rd. We plan to issue Intent to Award letters before the winter break so that contractors can evaluate the routes that they may or may not want to turn in by January 2nd.
- 4) Bid document updates: Page 10, Buses/Vehicle Qualifications, number 13 has been added. Requirements on Special Ed buses: red locking bag, evacuation blanket and seat belt cutter. Also on page 10, item 17, video camera requirements will continue however, be advised that an RFP has been issued for a camera system to include a stop arm camera. If a vendor is selected, then the contractor may not have to purchase the camera system for a new bus. It would be supplied by the new vendor.

REVIEWED CHANGES IN THE BID DOCUMENT.

- 1) Please see attached revised Attachment 2 Routes to be Bid.
- 2) Section II, Terms and Conditions, item H. Price Adjustment replace "Baltimore/Washington area" with "All Urban Consumers (CPI-U) Middle Atlantic, Transportation".

QUESTIONS & ANSWERS:

- 1) On Attachment #2 route R1353 is in zone 5/6 but on the price sheet it is in zone 3/6, and R1354 goes from zone 3/6 to zone 2/6 on the price sheet. Also, S1386 is designated as a Homewood route on the attachment but the price sheet does not. R1371 is listed as zone 2/6 and should be zone 6. Response: Please see the attached revised/corrected Attachment #2. Also, Route S1386 is a Homewood trip 4/6 S1386**. Please change the price sheet for Route S1386 to be \$1386**
- 2) Are you still requiring 70 passenger buses? Response: Yes
- 3) Will you evaluate base and extended rates for the award? Response: Yes.
- 4) Do you have special provisions for students that are displaced?

Response: Yes, per the bid specifications on page 7, Basis for Award, item # 13:

- 1. The time and mileage minimums and rates bid do not apply to extra routes that may be assigned including, but not limited to mid-day, work study/enclave, homeless and evening school/weekend trips and summer school routes. For Summer School routes, the minimum time and mileage will be 40 miles and 3.5 hours daily. Mid-day routes during the school year will be guaranteed 1.5 hours. Extended rates will be applied for all time and mileage beyond the stated minimums.
- 2. In addition, efficiencies and costs associated are evaluated.
- 5) What makes the Transportation Office add a 2nd attendant on the bus? Response: Behavior issues, IEP requirements, decision by transportation staff. Pre-K students may be riding on general education buses.
- 6) Is there a COLA included in the bid?

 Response: It will dependent on funding. The CPI reference is changed as noted above.
