

Procurement Procedures (HCPSS) - Robert Gill

- Robert Gill began by stressing that the bidding Prime Contractor's are responsible for including everything that is included in the Bid Documents regardless of whether it is specifically covered in this meeting.
- Bid Date: March 10, 2020 @ 1:00 PM Late Bids will not be accepted
- RFI Deadline: March 3rd @ 2:00 PM
- Bids must be delivered to The Board of Education of Howard County, Maryland at its Department of Education Building, Purchasing Office; 10910 Clarksville Pike; Ellicott City, MD 21042-6198. Purchasing Office located in the Portable 177 behind the Central Main Office. No need to check in at the Central Main Office.
- It is the bidders responsibility to acknowledge all addenda and confirm receipt of all addenda by contacting the CM prior to bid. Do not rely on 3rd party websites to obtain bidding documents. The only official bidding documents are those which are received from the CM and HCPSS website.
- Bidders shall include the Contract Package number and description on the sealed envelope. An Envelope Label has been included at the end of section 003000 – Form of Proposal, for



your use. You are not required to use this label but you are required to include all information included on the label or your proposal could be deemed non-responsive.

- 5% Bid Bond to be accompanied with bid
- Successful bidder will be required to provide 100% Payment and Performance Bonds
- Must be on Bid Form provided in Section 000300 Form of Proposal
- Robert Gill went over all specification sections included in Division 0 Bidding Requirements, highlighting key items. Please refer to the Bid Documents for details.

Project Summary (GWWO) - Brian Minnich

- In general, the project consists of the renovation of Forest Ridge Elementary School administration area as well as a vestibule addition to provide secure entry.
- Brian mentioned that a brick has been selected and will be specified in an upcoming addendum.

Additional Information (Dustin) – John Pickett

- All questions regarding the bid, or the Documents, are to be sent to Mr. Lloyd Hill, Dustin Construction, Inc. at, <u>LHill@DustinConstruction.com</u> with a copy to Mr. John Pickett, Dustin Construction, Inc. at <u>JPickett@DustinConstruction.com</u> no later than March 3rd at 2:00 pm. Questions shall be submitted in Word format. Only answers provided via an addendum issued by the CM/HCPSS will be binding.
- Carefully read the specifications, in particular, sections 001000-Notice to Bidders, 011112-Contract Package/Specification Cross reference, 011113-General Scope of Work and Trade Specific Scopes. If you are bidding one of the three Contract Packages (01A General Trades, 15A Mechanical, 16A Electrical), you are considered a "Prime Contractor". You are responsible for all Division 0 and 1 requirements.
- You must bid the entire scope and no qualifications are allowed to be submitted with your bid. If you submit your bid on something other than the bid form provided with the documents, your bid will be deemed non-responsive. Any modifications to the Bid Form will cause the bid to be non-responsive.
- Every bidder needs to carefully and completely familiarize themselves with the Bid Documents. Just because things were done in a certain way on a previous project does not necessarily mean they will be done the same on this project.
- No bids or minority forms are to be sent to the Dustin Office. All bids are to be submitted directly to HCPSS Purchasing Office.
- This site is school property and as such there is to be no smoking/vaping or consumption of alcohol on the premises.



- Limited onsite parking may be available as designated by the CM. Parking by Trade Contractor staff will be their responsibility.
- Reference section 011113-General Scope of Work-N.6 for project work hours. All Trades are required to work 6 days per week to meet the project schedule.
- A Preliminary Schedule (013100) has been issued with the bid documents. After award, the Construction Manager will solicit trade input on the schedule in regards to sequencing and durations.
- Site excavation is non-classified to design subgrades.
- The rest of the school will remain active during construction therefore, temporary partitions will be required. Reference Scope packages and temporary partition plan at end of specification section 013100.
- All existing systems which serve the rest of the school outside of the work area shall remain operational throughout construction. Any outages shall be coordinated with CM and Owner no less than 2 weeks prior.
- Any questions that are asked at the pre-bid meeting should be sent in writing for official answers via addendum.
- A site visit followed the meeting. Any future site visits shall be coordinated with Dustin by submitting your request in writing to Lloyd and John via email. Do not go to the school without prior approval.




