2	Joshua Kim	Autumn General Contracting	On drawing C-2 the drawing shows two 12" RCCP pipe sections that connect to structure M-2. These two pipe sections also connect into existing clean outs shown on the drawing. Please provide additional information and more detail concerning these existing clean outs.	The existing 1991 SDP does not call out the cleanouts as proposed that are existing in the field. The material is unknown. It should be assumed that a test pit / verification will be needed at time of construction to determine the material for making connection to and adjustments will need to be made then. Due to proximity to the existing building and school being in session, verification will need to be at time of construction. There is no additional information beyond what has been provided. The existing connecting pipe material was only called out as storm lateral on the existing SDP. 01A Contractor is responsible for all test pitting and field verification required.

6		Pre-Bid Questions	Please advise if the Owner will provide more of a staging/laydown area than what is currently shown within the LOD. Can we take the entire green space in front of the school?	Contractor will be allowed the additional green space in front of the existing school provided that they restore all condititions to preconstruction state. All disturbed areas to be sodded. Please see revised Site Utilization Plan with this addendum. 01A Contractor shall be reponsible for any additional Erosion and Sediment Control measures, tree protection, adjacent area restoration, etc. that will be required for this change.
7		Pre-Bid Questions	Once school is out of session, will parking be available on site?	Contractor will be allowed to utilize the school parking lot provided that they restore all condititions to preconstruction state.
8		Pre-Bid Questions	Does the Construction Entrance require a wash rack?	A wash rack is not required however, per 01A Scope item #25, the CM has the right to direct the 01A Contractor to install a wash rack should the 01A Contractor fail to maintain clean roadways and adjacent areas.
