#### Procurement Procedures (HCPSS) - Robert Gill

- Robert Gill began by stressing that the bidding Prime Contractors are responsible for including everything that is included in the Bid Documents regardless of whether it is specifically covered in this meeting.
- Bid Date: July 14, 2020 @ 1:00 PM
- RFI Deadline: July 6th @ 2:00 PM to Dustin
- Bids must be emailed per the Notice to Bidders
- It is the bidders responsibility to acknowledge all addenda and confirm receipt of all addenda by contacting the CM prior to bid. Do not rely on 3<sup>rd</sup> party websites to obtain bidding documents. The only official bidding documents are those which are received from the CM and HCPSS website.
- 5% Bid Bond to be accompanied with bid
- Successful bidder will be required to provide 100% Payment and Performance Bonds



- All bids must be on the complete Bid Form provided in Section 003000 Form of Proposal
- Any questions regarding the MBE requirements shall be submitted as an RFI prior to bid
- Robert Gill emphasized even though this project is constructing a new facility, it is still on a school site and it is unlawful to provide anyone on this project that does not pass the sexual assault and violent crimes background check.
- Robert Gill went over all specification sections included in Division 0 Bidding Requirements, highlighting key items. Please refer to the Bid Documents for details
- Dan Lubeley clarified to not visit the site at any other times other than the scheduled site visit.
- Dan Lubeley reminded bidders that Prior to hitting send on your submission ensure you are submitting all the required submission items.

# Project Summary (TCA) - Robyn Toth

- Robyn Toth went over the design of the new school and spoke to the floor plan, exterior elevations and materials, typical classrooms, gymnasium, cafetorium, media center, etc.
- Robyn Toth went over the final site plan and discussed that the new school is being constructed on the existing play fields while the existing school is occupied.
- Many colors have already been selected. Reference the Contract Documents for more information.
- This is a LEED Silver project. Bidders were reminded that the successful Contractors will be responsible for completing the LEED processing sheet before a shop drawing will be reviewed.
- Alternates were discussed and pointed out.
- Substitutions will not be considered during the bid process.

#### Additional Information (Dustin) - John Pickett

- Preliminary Schedule (013100) has been issued with Addendum #1. After award, the Construction Manager will solicit trade input on the schedule in regards to sequencing and durations.
- Discussed the site phasing:
  - Utility Relocation Work currently underway to be complete this summer
  - Phase 1 New School Construction (NTP Late Spring/Early Summer 2022)



- Phase 2 Begin demolition of the existing school to allow for completion of storm work and installation of paved areas (Summer 2022). John stressed the importance of this Summer phase and that all work must be completed by any means necessary to allow the school to open for the Fall 2022 school year. John also mentioned the need to move the school from one facility to the next.
- Phase 3 Complete demolition of the remaining school, complete the remaining site work to include the new athletic fields (September December 2022)
- Reference specification section 011112 Specification Cross Reference, 011113-Contract Packages including the General Scope of Work and Trade Specific Scopes. If you are bidding one of the Contract Packages, you are considered a "Prime Contractor". You are responsible for all Division 0 and 1 requirements. If you are bidding a portion of work which is included in one of the contract packages listed please contact Dustin for a list of Prime Contractors to send your bid to.
- You must bid the entire scope and no qualifications are allowed to be submitted with your bid. If you submit your bid on something other than the bid form provided with the documents, your bid will be deemed non-responsive. Any modifications to the Bid Form will cause the bid to be non-responsive.
- No bids submissions are to be sent to Dustin. All bids are to be submitted electronically directly to HCPSS Purchasing office at the specific email provided.
- Limited onsite parking may be available as designated by the CM. Parking by Trade Contractor staff will be their own responsibility.
- Site excavation is un-classified to design subgrades. There are unit prices provided in the bid documents for additional work required beyond what is required per the Contract Documents.
- The existing school will remain active during construction. No disruptions to the existing school will be tolerated. Deliveries will not be allowed during drop off and pick up times.
- A site visit is scheduled for July 1<sup>st</sup> @ 12:30pm. All interested Contractors shall email <u>bids@dustinconstruction.com</u> and provide the names and contact information for all attendees by COB Monday June 29th. Please note that groups touring the inside of the existing school will be limited to 10 at a time to comply with social distancing requirements and therefore there may be a waiting period to enter the building. Please limit the number of attendees to 1 representative from each firm. There will only be one site visit. We will issue this information in the next addendum.

# Final Remarks

- Robert Gill reiterated to use the bid form provided in the documents.
- Dan Hagan stressed that no disruption to the existing school will be tolerated.
- Dan Hagan stressed that if you are bidding one of the Trade Packages you are a Prime Contractor and are responsible for providing all the necessary bonds, etc.
- Dan Hagan stressed that face masks will be required at the site visit.
- Dan Lubeley stated that all Prime Contractors are responsible for their own safety protocols during construction in regards to typical safety as well as COVID-19 protocols. HCPSS will require that you follow CDC and any State guidelines however HCPSS will not enforce further guidelines.
