2. Is full time on-site supervision required from the prime contractor or will it be acceptable for the elevator contractor's foreman to act as the supervisor when only elevator-specific work is taking place?

Response: Prime contractors are responsible for all subcontractor activities and must have representation at all times they are on-site performing work.

3. Please confirm that this project will not be subject to prevailing wage law requirements if the final total contract sum is below \$250,000.

4. Please confirm that this project is not subject to Buy American Steel Act.

Response: This project is subject to the Buy American Steel Act.

5. Will the contractor be given access to the bathrooms on-site?
