B. Unit Prices

1. For scraping and priming of more/less surface rusted areas of steel deck and framing than the fifteen hundred (1,500) square feet carried in the Base Bid as outlined in Division 05 Section "Steel Decking."

2. For removal and replacement of more/less steel deck than the five hundred (500) square feet carried in the Base Bid as outlined in Division 05 Section "Steel Decking."

ADD/ DEDUCT _____/per square foot

3. For the installation of more/less walkway pad than the eighteen hundred (1800) linear feet carried in the Base Bid, as outlined in Division 07 Section "Thermoplastic Roofing."

ADD/ DEDUCT _____/per linear foot

Unit Prices shall be used should the work be increased or decreased during construction. The unit prices will be the basis of compensation for additions or reductions to the quantity of work covered by the allowances.

Final contract price will be adjusted at completion of work to give the Owner credit for any unused quantities of Unit Price items. Credit shall be given at same prices quoted above. Any additional quantities required, over and above quantities stated in this Proposal, will be added to the contract by Change Order, at the Unit Prices quoted above.
