The following shall be incorporated into the captioned solicitation as though included in the original documents issued.

The Board of Education authorizes the following changes, clarification and/or attachments to the solicitation documents; however such changes shall not relieve the firm of their responsibilities as otherwise required by the solicitation documents.

Questions

- Question : Per Addendum #1/question #1, "you cannot propose several substitute products." What Safety Surfacing would HCPSS prefer to use? How will HCPSS evaluate product vs cost? For example – Vendor A submits Rubber Tile over asphalt, then during Phase III of the selection process, Vendor A will always be more expensive vs if Vendor B used Bonded Rubber over compacted stone.
 - Answer: Both surfaces are acceptable regardless of how it may affect the individual contractors pricing.
- Question : Page 28, states designs shall not include roofed areas. Shade is critical to Playgrounds and often a requirement. It can be difficult and expensive to add on later. Should shade be included?
 - Answer: No, at this time HCPSS is not including any shade implements in its specifications for new playground installations.
- 3. Question : For bidders who represent a manufacturer, will you accept the Maryland Business License of the installing subcontractor?

Answer: Yes!

4. Question : We use multiple sub-contractors; will all the subcontractor licenses be required in the bid documents, or can we submit one installer license?

- Answer: I would suggest submitted all subcontractors license that the contractor may plan on using.
- 5. Question : The bid includes poured in place surfacing or playground tile which has substantially increased in price. Will you accept design submissions that may not meet budget but do meet the design criteria?
 - Answer: No, all design submissions must meet the Budget requirements of the solicitation documents.
- 6. Question : The new standard in Howard County is to include a communication board on school and park playgrounds. Will this board be supplied by the bidding contractor or Howard County Public Schools and shall the installation of the communication board be included in the bid?
 - Answer: The installation of communication boards will not be included in this contract. This process goes through a different department with separate funding specifically for the boards.
